## 2. Purposes and legal basis for the Personal Data processing

### Processing based on consent pursuant to Article 6(1) lit. a GDPR

We will process your Personal Data (your name, (email) address) if you granted prior consent to keep you up to date on ours latest webinars, courses and services.

Any withdrawal has no effect on past processing of personal data by Movens Capital up to the point in time of your withdrawal.

### Processing to fulfill contractual obligations pursuant to Article 6(1), lit. b GDPR.

If you order webinars, courses or other services from Movens Capital, we will use the Personal Data that you enter into the order or registration form (usually (a subset of) your name, (email) address, telephone number, company name and address, your job title and role) only to process your order or to provide the requested service. This may include taking the necessary steps prior to entering into the contract, responding to your related inquiries, processing your feedback, providing you with support, sending notice of payments.

**Generally, you cannot opt out of these communications** because these communications are required for the relevant business relationship and not marketing-related in nature.

## Processing based on Movens Capital legitimate interest pursuant to Article 6(1), lit. f GDPR

We can use your Personal Data based on our legitimate interest as follows:

## 3. Period of which you Personal Data will be retained

We will store your Personal Data only as long as it is necessary

- If we are processing your Personal Data based on your consent, we will retain your data until you revoke your consent.
- If we are processing your Personal Data based on legitimate interest, we will retain your data until you object against such use.
- where your Personal Data is required for Movens Capital to assert or defend against legal claims, we will retain your data until the end of the relevant retention period or until the claims in question have been settled.

#### 4. Your rights

You can request from us access at any time to information about which
Personal Data we processes about you and the correction or deletion of such
Personal Data. Please note, however, that we can delete your Personal Data
only if there is no statutory obligation or prevailing right of Movens Capital to
retain it.

- You can request from us a copy of the your Personal Data undergoing processing. Furthermore If we process your data based on your consent or to perform a contract with you, you can request a copy of data that you provided to us in a structured, commonly used and machine-readable format to electronically transfer it to another Data Controller (data portability).
- You can request from us, that we will restrict your Personal Data from any further processing in following cases: (i) you state that the Personal Data is incorrect, (ii) there is no legal basis for processing your Personal Data but you oppose to erasure and request restriction instead, (iii) we no longer requires your Personal Data but you state that you require us to retain such data in order to claim or exercise legal rights, (iv) in case you object to the processing of your Personal Data based on Movens Capital legitimate interest subject to the time required by us to determine if our legitimate ground override your objection
